The monthly Business Meeting of the Board of Education was held Monday, January 22, 2013, in the Roosevelt School Library Learning Center. Below is a summary of the meeting.

#### Call Meeting to Order/Roll Call

The meeting was called to order at 7:32 p.m. All members were present.

#### **Communications**

David Latham read two thank you notes from staff members for condolences from the District.

## **Freedom of Information Act Request**

One request for payment bond information was received on January 2, 2013. The response was mailed on January 3.

### **Student Presentations**

- Braiden, 4<sup>th</sup> Grade, Willard School, reported about class activities, including second graders switching classes for some subjects, which is new this year. The third grade is participating in the Second Step behavior improvement program. Fourth grade is learning the role Native Americans played in Illinois history.
- Nick, 7<sup>th</sup> Grade, Roosevelt Middle School, gave a Power Point presentation about school instruction and activities using his iPad. The 5<sup>th</sup> graders are practicing for Readers Theater, and 6<sup>th</sup> graders are writing memoirs and studying weather in science. The 7<sup>th</sup> graders are writing thesis papers on science fiction books, and studying bacterial and viral diseases in science. The 8<sup>th</sup> graders are making iMovies. Rehearsals are under way for Music Man, orchestra and jazz band workshops, and other performances.

## **District Meetings**

- A. River Forest Administrators' Forum

  Ed Condon reported that the group discussed new policies related to use of Village property for gatherings of more than 50 people.
- B. Teacher Leadership Council (TLC): At the meeting, the TLC members continued their focus on Advanced Differentiated Learning, including discussion about gifted and talented identification and the creation of related sub-committees.
- C. Superintendent's Leadership Council (SLC): Discussion items included the topics of Response-to-Intervention, ongoing preparations for the transition to the Common Core curriculum, and Summer School 2013.
- D. District PTO Council: The January meeting included several parents who shared information about District 90 allergy policies and procedures. The group also discussed Advanced Differentiated Learning (ADL), the Roosevelt exterior project, and upcoming February events scheduled at each school.

## **Superintendent's Report**

**Action Items:** 

- 1. Resolution amending the Resolution approving the dissolution of FDSE, due to lack of clarity. There was a motion to amend the FSDE dissolution agreement. Approved
- 2. Selection of landscape architect: Seven proposals were received and reviewed, then narrowed to three finalists. A panel interviewed the three finalists. The committee recommended selection of Hitchcock Design Group, pending negotiation of the terms and budget. Approved
- 3. Instructional supplies: The Board must annually approve the solicitation of bids for instructional supplies. Approved

#### **Informational Items:**

- Receipt of Audit Report for the 2011-2012 fiscal year. Colleen DeKraker, Senior Manager from Miller, Cooper & Co., Ltd., presented the Audit Report. The District received a clean audit opinion.
- 2. 2013 Financial Profile Designation: A report from the Illinois State Board of Education was provided to the Board. District 90 received the highest ratings in each area. Ed Condon acknowledged those responsible for the District's financial health for their ongoing commitment and "Financial Recognition" status.
- 3. Policies, first readings: 6:170 Title 1 programs

6:15 – School accountability

Roman Ebert presented background regarding the District's past position on accessing Title 1 funds in District 90. Increases in available funding for the coming year were also discussed. The Board requested more information and further discussion will take place at a future meeting.
