District Meetings Agendas

- A. Superintendent's Leadership Council (SLC): The Council's last meeting focused on review of gifted and talented programming. Recommendations for further work will be presented at the December 17 Board of Education meeting.
- B. District PTO Council: The group discussed Institute Day, the Common Core initiative, higher ability learners, and the status of the iPad deployment. Dr. Condon mentioned that District students are fortunate to have such supportive parent groups.
- C. Teacher Leadership Council (TLC): Common Core implementation and Response to Intervention (RtI) are among the current areas of focus.

Superintendent's Report

Informational items were presented.

- A. School Board Member Appreciation Day, November 15: Dr. Condon expressed appreciation to the Board members for their service.
- B. Policy Updates, October 2012, First Reading: Roman Ebert and Dr. Condon met in advance to review a number of District policies. Roman Ebert presented recommended policy changes to the Board.
- C. 2012 SchoolSearch Bright A+ Award: Dr. Condon displayed the award, noting that this is the 14th year in a row that the District received this honor related to student performance.

D. Operating Fund Financial Projections, 2014-017: Ralph Martire, James Weiss, Ed Condon, and Anthony Cozzi met in advance to discuss the projections. Anthony Cozzi presented the five-year projections to the Board of Education and answered questions. At the conclusion of the presentation, Ralph, Anthony, and Ed presented the recommendation to approve the 2012 Estimated Tax Levy with a one-year rate freeze.

Action Items:

- 1. 2012 Estimated Tax Levy: Approved.
- 2. Selection of Civil Engineer: Three firms were sent a Request for Qualifications. Two responded and both were qualified. Terra Engineering was determined to be the best fit for the projects, and was recommended for Board approval. Approved.
- 3. FY2013 School District Library Program Grant: The Illinois Secretary of State makes funds available (about \$1000) to enhance library services. Thanks was expressed to Marcia Ryan, Willard School Librarian, for her assistance in preparing the grant for submission. The Board approved assurances related to fulfilling the grant, if received.
