Literature Review Update

- Committee reviewed research related to the following foundational reading components:
 - Phonemic awareness
 - Phonics
 - Fluency
 - Vocabulary/word study
 - Comprehension
 - English Learners
 - Students with learning difficulties
 - Print vs digital resources
- Completed the review of research and effective instructional practices in December
- Document will be finalized and publicly shared in late January



Materials Review: Paper Screening Process

- Organized vetting team sub-committee by grade-level band: K-2, 3-5, 6-8
- Developed paper screening rubrics for each grade-level band
- Criteria sourced from Ed Reports, Institute of Education Sciences (IES), and The Reading League
- Conducted review of Ed Reports to determine if materials met alignment and usability gateway expectations
- Illinois State Board of Education rubric to be finalized July 2024

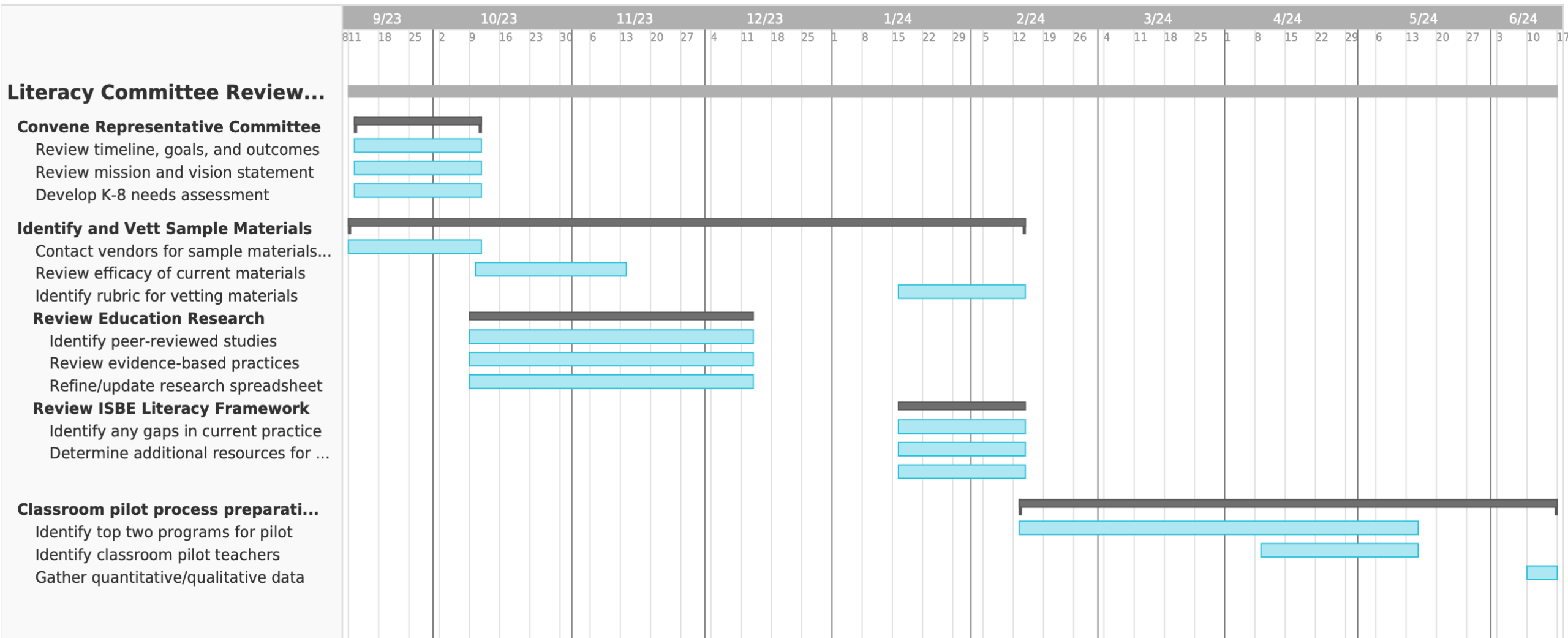
